

## Harford Film Camp -- RELEASE AGREEMENT

I understand that I and/or my minor child may voluntarily appear "on camera," or have my/his/her image and/or voice recorded for use in a Harford Film Camp production. In consideration of good and valuable services, including educational services, the receipt of which is hereby acknowledged, I hereby grant permission to Harford Film Camp and David W Warfield, their licensees, successors, legal representatives, and assigns, the absolute and irrevocable right and permission to use, reproduce, edit, exhibit, project, display, copyright, or publish still images and/or print and/or moving pictures and/or videotaped images of me and/or my minor child, with or without my and/or my child's voice or name, or in which me and/or my minor child may be included in whole or in part, photographed, videotaped, and/or recorded, and to circulate the same in all forms and media for art, advertising, trade, competition of every description and/or any other lawful purpose.

I understand that the purpose of Harford Film Camp is educational, and that Harford Film Camp is not contractually obligated to produce, finish, or deliver video or sound recordings, films, or other media, and that Harford Film Camp is not responsible for the loss or destruction of video or sound recordings, due to accident, weather, technical failure, or any other reason, and that due to the nature of the filmmaking process, unforeseen events may occur which could make completion of a film project impossible. Nevertheless, Harford Film Camp intends, in good faith, to produce one short film per session/ group, and to actively encourage the participation of enrolled students in technical and creative roles. Harford Film Camp grants participants the use of the short film for non-commercial purposes only, including screening for family and friends, as resume or portfolio content, or other casual non-commercial purposes.

I hereby waive any right that I may have to inspect and/or approve the finished product or any right that I and/or my minor child may have to control the use to which said product, video and/or soundtrack or copies thereof may be applied. I hereby release, discharge and agree to save Harford Film Camp and David W Warfield, their licensees, successors, legal representatives and assigns from any liability by virtue of any blurring, distortion, alteration, whether intentional or otherwise that may be produced in the making, processing, duplication, or displaying of said picture or images, and from liability for violation of any personal or proprietary right that I and/or my minor child may have in conjunction with said pictures or images and with the use thereof. I understand that any film, video, sound or picture recording produced by Harford Film Camp and David W Warfield are the sole property of Harford Film Camp and David W Warfield, and that they have exclusive and total ownership, copyright, and right of use in any and all media, or any other use or rights deriving from Harford Film Camp productions.
